EMERGENCY PROCEDURES

24 HOUR ADVICE IN AN EMERGENCY ONLY: 0800 734 607

IF THIS HAPPENS	DO THIS
Tanker/Vehicle Accident	Switch off engine and electrical equipment. Keep people away, warn other traffic. Check for spills, leaks. Call the emergency services: Dial 111
Spill or leak	Keep all bystanders away. Wear goggles, half face-piece respirator with combined dust and vapour cartridge, full length clothing and PVC gloves. Adsorb spilled product and place in a sealable container for disposal. Wash down affected area with water plus detergent. Seek advice from local authority regarding disposal.
Fire	Call the Fire Service: Dial 111. Wear PVC protective clothing and breathing apparatus. Suitable extinguishing media: water spray, Carbon dioxide (CO2), Foam, Sand. During a fire toxic fumes may be released. Contain run-off. Keep non-involved persons away.

FIRST AID

If Swallowed:	Rinse mouth. Do NOT induce vomiting. Contact the National Poisons Centre 0800 POISON (0800 764 766) or a doctor immediately.
If in Eyes:	Rinse immediately with plenty of water, also under the eyelids, for at least 15 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Get medical attention if irritation develops and persists.
If on Skin:	Wash off thoroughly with plenty of soap and water, if available with polyethyleneglycol 400, subsequently rinse with water.
If Inhaled:	Move to fresh air. Keep patient warm and at rest. Call a physician or poison control centre immediately.

STORAGE AND SEGREGATION SUMMARY

Storage: Store in original container in a cool, dry, ventilated place away from direct heat or direct sunlight. Store away from foodstuffs, children and animals. Keep container sealed when not in use.

Aggregate Storage Volume Thresholds: When stored with substances of the same hazard the aggregate quantity must be considered. For full details refer to the current NZS8409 Management of Agrichemicals and the HSNO Regulations.
