PRECAUTIONS:

Contain the spill by damming, recover spilt product by absorbing with sawdust or an inert absorbent material then transfer the recovered spilt material to a properly labelled drum. Disposal: Dispose of this product only by using according to the label or at an approved landfill. Avoid contamination of any water supply with product or empty container.

Container Disposal: Triple rinse container and add residue to mixture. Take to an Agrecovery collection site.

If skin contact occurs, remove contaminated clothing and flush skin with running water. If splashed in eyes wash out immediately with water. If inhaled move the victim to fresh air immediately.

DIRECTIONS FOR USE:

Mixing: Half fill the spray tank with water then pour in the required quantity of Luna Privilege with agitators running, then top up with water.

RESISTANCE MANAGEMENT:

Luna Privilege contains fluopyram from the SDHI (Succinate Dehydrogenase Inhibitor) mode of action (Group 7). Resistance to this fungicide and related products could develop



in some disease situations from repeated use. To minimize this risk follow label directions and use a maximum of 2 applications per season. Make no more than 2 applications using fungicides from the SDHI group.

RECOMMENDATIONS:

The rates recommended are for high volume spraying to the point of run-off. For concentrate spraying adjust dilution rate accordingly.

Crop	Disease	Rate	Remarks
Kiwifruit	<i>Sclerotinia</i>	300 ml/ha	Apply in 1000-1600 litres of water/ha without excessive run-off. Make a single application from 7 days prior to the start of flowering up to 80% flowering. Do not allow stock to graze treated orchards.
Greenhouse fruiting vegetables (except cucurbit) e.g. Tomatoes, Capsicums, Aubergines, Chilli	<i>Botrytis cinerea</i>	600 ml/ha	Apply preventatively when conditions are favourable for disease development. A second application may be necessary but must not be applied consecutively. Use a water rate to ensure complete coverage. Make no more than 2 applications per crop.

COMPATIBILITY:

Luna Privilege is compatible with commonly used insecticides and fungicides. It is advisable to test plant compatibility of mixtures on a small experimental area first.

RESTRICTIONS

The maximum application rate for Luna Privilege is 300 mL/ha (equivalent to 150 g/ha of fluopyram), with a maximum of one application in any 365 day period, except when it is used in greenhouses on crops separated from the soil.

The maximum application rate for Luna Privilege when used in greenhouses on crops separated from the soil is 600 mL/ha (equivalent to 300 g/ha of fluopyram), with a maximum of two applications in any 365 day period, and a minimum interval between applications of seven days.

Must be applied via ground-based methods only.

Restricted entry intervals if no gloves are worn when used in greenhouses – 13 days

It is an offence for users of this product to cause residues exceeding the relevant MRL in the Food Notice: Maximum Residue Levels for Agricultural Compounds.

WITHHOLDING PERIOD:

Kiwifruit — Do not apply after 80% flowering.

Greenhouse fruiting vegetables (except cucurbits) – 1 day
