Teldor® contains fenhexamid from the SBI Class III mode of action (Group 17). Resistance to this insecticide and related products could develop in some pest situations from repeated use. To minimize this risk, use strictly in accordance with label instructions. Do not use more than 2 applications of Teldor in the same crop during the same season.

RECOMMENDATION:

Crop	Disease	Product Rates	Comments
Grapes	Botrytis	75 ml/100L or a minimum of 750 ml/ha	Make two applications at pre-brunch closure and veraison or at veraison and again 14 days later. Apply in sufficient water to achieve good coverage of the bunches
Boysenberries Strawberries	Botrytis	150 ml/100L or a minimum of 1.5 L/ha	Make two applications over the flowering period ensuring good coverage of the flowers
Lemons Oranges Mandarins	Botrytis	100 ml/100 L	Make two applications as a full cover spray to point of run-off at full open flowering

Teldor is compatible with commonly used fungicides and insecticides.
