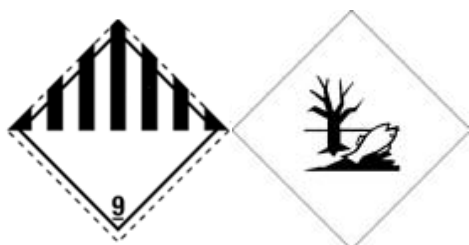

Contain the spill by damming, recover spilt product by absorbing with sawdust or an inert absorbent material then transfer the recovered spilt material to a properly labelled drum. Deal with all spillages immediately. If contamination of drains, streams, watercourses, etc. is unavoidable, warn the local water authority.

**Disposal:** Dispose of this product only by using according to the label or at an approved landfill. Avoid contamination of any water supply with product or empty container.

**Container Disposal:** Triple rinse container and add residue to mixture. Take to an Agrecovery collection site.

Pour Confidor directly into the spray tank with agitators running.

#### RESISTANCE MANAGEMENT

Group	4A	Insecticide

Confidor contains a group 4A insecticide and belongs to the neonicotinoid group of chemicals. Resistance to this insecticide could develop from excessive use. To minimise this risk use strictly in accordance with label instructions and resistance management strategies ([www.nzpps.org/resistance](http://www.nzpps.org/resistance)) that exists for any insect pest on this label.

#### RECOMMENDATION:

Crop	Pest	Rate	Remarks
Onions	Thrips	225ml/ha	Apply first application when monitoring of thrips levels indicates the threshold level has been reached. Repeat applications at 7-10 day intervals as a cluster of a maximum of 4 applications. Use in 500-600L of water/ha. The addition of a wetting agent is suggested. Ensure good spray coverage. Refer to the Resistance Management statement.
Vegetable brassicas (cell transplants)	Cabbage aphids	9ml/2.5 litres of water per 1000 plants	Apply evenly in a watering can to seedling trays 1 day before transplanting.
Lettuce (cell transplants)	Aphids	20-30ml/2.5 litres of water per 1000 plants	Apply evenly in a watering can to seedling trays 1 day before transplanting
Grapes – young non-bearing vines and vines for removal	Mealybug	1.5ml/vine in 500ml water per vine	Apply as a single soil drench treatment in autumn or winter around the base of non-bearing replant vines or vines awaiting removal. Ensure the treatment covers the rooting area of the vines. If rainfall or overhead irrigation is not likely in the 2 days after drenching, apply 2L of water per vine once the drench has soaked in.
