Mesuro! Pro Snail and Slug Bait is specially formulated for control of slugs and snails where these pests are a problem. The bait is odourless and is specially formulated to attract snails and slugs, remaining effective for several weeks after application.

It is an offence to use this product on animals.

DIRECTIONS FOR USE:

Simply sprinkle the bait on the area to be treated so that the baits are 8-10 cm apart or 100 baits per 1 square metre. Good results are also obtained by sprinkling a band around beds or by scattering evenly between plants. Do not pile the bait. On a per hectare basis, it is suggested that the baits be broadcast or banded by use of granule applicators at the rate of 6 kg per hectare.

WITHHOLDING PERIOD:
