Movento OD is a systemic (xylem- and phloem-mobile) insecticide belonging to the chemical class of ketoenols for the control of tomato/potato psyllid in field tomatoes and potatoes, and green peach aphid in potatoes.

DIRECTIONS FOR USE:

MIXING: Pour **Movento OD** directly into the spray tank with agitators running.

RESISTANCE MANAGEMENT

Movento OD belongs to Mode of Action Group 23 (lipid synthesis inhibitors). Resistance to this insecticide could develop in some situations from repeated use. To minimize this risk, use strictly in accordance with label instructions. Do not apply more than 3 applications per season.

RECOMMENDATION:

Field Tomatoes	Tomato/Potato psyllid	560mL/ha	Make two applications early in the season at 7 day intervals as part of a programme, in sufficient water to ensure good coverage of all foliage. If large numbers of adult tomato/potato psyllid are present, add a knockdown insecticide

COMPATIBILITY:

Movento OD is compatible with most fungicides and insecticides.

Do not mix with chlorothalanil and foliar fertilisers.

Do not mix with adjuvants until crop safety has been tested.

EPA RESTRICTIONS:

The maximum application rate for Movento OD is 560 ml product/ha (equivalent to 89 g ai/ha), with a maximum of three applications with an interval of seven days. Movento OD shall be applied via ground-based methods only.

It is an offence for users of this product to cause residues exceeding the relevant MRL in the Food Notice: Maximum Residue Levels for Agricultural Compounds.

WITHHOLDING PERIOD:

Field Tomatoes and Potatoes.....35 days
