PRECAUTIONS:

Do not eat, drink or smoke while using.

DIRECTIONS FOR USE:

Mixing: Shake well before use. Half fill the spray tank with water then pour in the required quantity of Velum Prime with agitators running, then top up with water.

RECOMMENDATIONS:

Crop	Pest	Rate	Remarks
Carrots and parsnips	Root Knot Nematode	1.25 L/ha	<p>Apply in 200 L of water/ha. Apply as a broadcast spray and immediately incorporate into the soil prior to planting. Make the application as close to planting as possible.</p> <p>Do not use Velum Prime on carrot or parsnip cultivars that will be harvested within 100 days of planting e.g. baby carrots and baby parsnips.</p>

RESTRICTIONS:

The maximum application rate is set at 1.25L product/ha, with a maximum of one application to the same area in any 365 day period

It is an offence for users of this product to cause residues exceeding the relevant MRL in the Food Notice: Maximum Residue Levels for Agricultural Compounds.

RESISTANCE MANAGEMENT:

Velum Prime contains fluopyram which inhibits the nematode generation of cellular energy. Resistance to this nematicide could develop in some situations from repeated use. To minimise the risk of resistance use accordingly to instructions on the label.

Carrot and Parsnip— 100 days
