| IF THIS HAPPENS | DO THIS |
|--------------------------------|---|
| Tanker/Vehicle Accident | Switch off engine and electrical equipment. Keep people away, warn other traffic. Check for spills, leaks. Call the emergency services: Dial 111 |
| Spill or leak | Keep all bystanders away. Wear goggles, half face-piece respirator with combined dust and vapour cartridge, full length clothing and PVC gloves. Adsorb spilled product and place in a sealable container for disposal. Wash down affected area with water plus detergent. Seek advice from local authority regarding disposal. |
| Fire | Call the Fire Service: Dial 111. Wear PVC protective clothing and breathing apparatus. Extinguish fires with foam, dry chemical or carbon dioxide. During a fire toxic fumes may be released. Contain run-off. Keep non-involved persons away. |

| If Swallowed: | Do NOT induce vomiting. For advice contact the National Poisons Centre 0800 POISON (0800 764 766) or a doctor immediately. |
| If in Eyes: | Rinse immediately with plenty of water, also under the eyelids, for at least 15 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Get medical attention if irritation develops and persists. |
| If on Skin: | If skin or hair contact occurs, remove contaminated clothing and flush skin and hair with running water. Get medical attention if irritation develops and persists. |
| If Inhaled: | Remove patient to fresh air. If not breathing, give artificial respiration, preferably mouth-to-nose. Get medical attention if symptoms develop. |

STORAGE AND SEGREGATION SUMMARY

Storage: Store in original container in a cool, dry, ventilated place away from direct heat or direct sunlight. Store away from foodstuffs, children and animals. Keep container sealed when not in use.
