4.1 Description of first aid measures

The tumours seen with Fluopyram were caused through a non-genotoxic mechanism, which is not relevant at low doses. The mechanism that triggers these tumours is not relevant to humans. Triadimenol caused at high dose levels an increased incidence of tumours in mice in the following organ(s): Liver. The increased tumour incidence is not considered to be treatment related.

Assessment toxicity to reproduction

Fluopyram caused reproduction toxicity in a two-generation study in rats only at dose levels also toxic to the parent animals. The reproduction toxicity seen with Fluopyram is related to parental toxicity. Triadimenol caused reduced fertility, reduced lactation rate. The reproduction toxicity seen with Triadimenol is related to parental toxicity.

Assessment developmental toxicity

Fluopyram caused developmental toxicity only at dose levels toxic to the dams. The developmental effects seen with Fluopyram are related to maternal toxicity. Triadimenol caused developmental toxicity only at dose levels toxic to the dams. The developmental effects seen with Triadimenol are related to maternal toxicity.
