IF THIS HAPPENS	DO THIS
Tanker/Vehicle Accident	Switch off engine and electrical equipment. Keep people away, warn other traffic. Check for spills, leaks. Call the emergency services: Dial 111
Spill or leak	Keep all bystanders away. Remove all sources of ignition. Wear goggles, respirator with a particle filter mask, full length clothing and nitrile rubber gloves. Do not allow to get into surface water, drains and ground water. Use mechanical handling equipment and keep spilled product in suitable, closed containers for disposal. Seek advice from local authority regarding disposal.
Fire	Call the Fire Service: Dial 111. Wear PVC protective clothing and breathing apparatus. Suitable extinguishing media: water spray, carbon dioxide (CO ₂), foam, sand. During a fire toxic fumes may be released. Contain run-off. Keep non-involved persons away.

FIRST AID

If Swallowed:	Rinse mouth. Do NOT induce vomiting. Contact the National Poisons Centre 0800 POISON (0800 764 766) or a doctor immediately.
If in Eyes:	Rinse immediately with plenty of water and seek medical advice. Contact the National Poisons Centre 0800 POISON (0800 764 766) or a doctor immediately.
If on Skin:	Wash off thoroughly with plenty of soap and water. If symptoms develop and persist, call a doctor.
If Inhaled:	Move to fresh air. Keep patient warm and at rest. Call a doctor or the National Poisons Centre 0800 POISON (0800 764 766) immediately.

STORAGE AND SEGREGATION SUMMARY

Storage: Store in original container in a cool, dry, well-ventilated place away from direct heat or direct sunlight. Store away from foodstuffs, children and animals. Keep container sealed when not in use.
